- 3. Landscape/Violation Elimination Plan: this program was discussed at the previous meeting however there is no new update. The board hopes this will reduce the negative interactions with homeowners.

Design Review Committee:

One Board Member also reported that the construction sites next to the alley are leaving nails in the alley where cars can run them over. CPM will be contacting the contractors to get this cleaned up.
